Confiserie Sprüngli AG Dietikon



Chocolate manufacturer Confiserie Sprüngli AG managed to reduce energy consumption for its production operations by 18.4% and at its Paradeplatz site by 16%. This in turn reduced its CO₂ emissions by a total of 72.6 tonnes per year. By entering into a target agreement with EnAW, Confiserie Sprüngli AG accessed a number of benefits. That includes ewz.effizienzbonus and the associated reduction of their electricity bills, CO₂ reimbursements, and efficiency improvements that have a positive impact on energy costs.

Selected measures

- Waste heat utilisation optimised
- Commercial refrigeration plant replaced
- Lighting upgraded to LED

Stadelhofen and Hohe Promenade cantonal schools Zurich



The two cantonal schools decided to carry out an operational cost optimisation with energo, part of the EnergieSchweiz programme. The aim is to improve overall energy efficiency in existing public and private buildings using the building technology at hand. This resulted in a reduction in energy consumption of around 8%.

Selected measures

- Lighting upgraded to LED
- Heating profile optimised and adjusted
- Operational mix of oil/gas optimised

Barclays Bank (Suisse) SA Geneva



As a bulk consumer, Barclays Bank (Suisse) SA in Geneva was ordered by the Geneva cantonal energy office (OCEN) to carry out a cantonal energy audit. In further analysis, we worked together to identify measures with a savings potential of around 8%. The primary focus of an energy audit, or energy consumption analysis, is operational optimisation – in other words, measures with high economic efficiency.

Selected measures

- Heating decoupled from hot water
- Mixer circuit regulator optimised
- Air flow in the computing centre optimised
